Alei Tzion – Annual General Meeting - 2011

We are writing to inform you that this year's Alei Tzion AGM will be held on **Sunday 8th May 2011** at LSJS. Voting will commence at 9am and will close at 10am. The AGM will start at 10am.

Any nominations must be made on the form enclosed with this letter and be received at the synagogue office before **3pm on Friday 22nd April 2011**. All nominations received after that time will be invalid.

Please note that a candidate will not be eligible for election unless he or she has signed that he/she is willing to stand for election and to act in accordance with the terms of the United Synagogue Constitution. No person shall be duly nominated unless he or she shall have been nominated by at least three members who are themselves qualified to vote (or nominate) under the United Synagogue Bye-Laws. A candidate may not stand for more than one local Honorary Officer position.

The persons entitled to vote or nominate at the elections must be members of this synagogue and shall not be more than a year in arrears in payment of their accounts to the United Synagogue.

Please note that a list of candidates, who have been duly nominated for various positions, will be sent to all members at least 7 days' prior to the AGM.

We would like to encourage as many members as possible, to play an active role in the running of Alei Tzion, and so contribute to the direction and decision making of the Community. There are five Honorary Officers positions, Chairman, Vice Chairman (or two co-chairs), Financial Representative and two Gabbaim. There will also be the following seven positions Events, Children, Education, Communications, Welfare, Fundraising and Membership.

1. Three members of Alei Tzion who are in every respect qualified to vote must nominate each person.
2. Qualifications for voting: The persons entitled to vote at the elections must be members of Alei Tzion of the age of eighteen years and upwards who shall during the whole of the six months immediately preceding the date of the election have been members of any Member Synagogue of the United Synagogue (or Affiliated and Associate Synagogues), and shall not be more than a year in arrears in payment of their membership accounts to the United Synagogue.
3. Any nominations must be made on the enclosed form and be received at the address below on or before Friday 22nd April 2011. All nominations received after that date or containing a greater number of names than there are respectively offices to be filled would be invalid.
4. Qualification for Election. Candidates for election must be, on 22nd April 2011, in the case of a) and d) above, male members of Alei Tzion, and in the cases of b), c) and e) above male or female members of Alei Tzion. In all cases they must be of the age of 18 years and upwards and not more than one year in arrears in payment of their membership accounts and shall during the whole of the year preceding this date been a member of any Member Synagogue of the United Synagogue.
6. In addition following the election of the Board of Management, representatives will need to be appointed to the Council of the United Synagogue
